# No. of malnourished in India declined in 15 yrs

of undernourished people in India has declined in the last 15 years to 224.3 million in 2019-2021, according to a UN report, which also said that there are more obese adults and anaemic women in the world's second most populous country.

The State of Food Security and Nutrition in the World 2022 report, issued on Wednesday by UN agencies Food and Agriculture Organisation (FAO), International Fund for Agricultural Development (IFAD), UNICEF, World Food Programme (WFP) and the World Health Organisation (WHO), said that the number of people affected by hunger globally rose to as many as 828 million in 2021, an increase of about 46 million since 2020 and 150 million since the outbreak of the Covid-19 pandemic.

The report said that in India, the number of undernour ished people declined to 224.3 million in 2019-21 from 247.8 million in 2004-06. It said that the number of children under 5 years of age who are stunted declined to 36.1 million in 2020 from 52.3 million in 2012, the

number of children under five years of age who are over-weight declined to 2.2 million in 2020 from three million in 2012. However, the number of obese adults in India, which has a population of over 1.4 billion, grew to 34.3 million in 2016 from 25.2 million in 2012 and the number of women aged 15 to 49 years affected by anaemia also grew to 187.3 million in 2019 from 171.5 million in 2012. The report added that the number of children up to 5 months of age exclusively breastfed touched 14 million in 2020 from 11.2 million in 2012.

In percentage terms, the prevalence of undernourishment in the total population

in Indiastood at 21.6% in 2004-06 and declined to 16.3% in 2019-21, the prevalence of stunting in children under 5 years of age declined to 30.9% in 2020 from 41.7% in 2012 and the prevalence of overweight children under five years of age was 1.9% in 2020 from 2.4% in 2012.

The prevalence of obesity in India's adult population increased to 3.9% in 2016 from 3.1% in 2012 and anaemic women aged 15 to 49 years declined from 53.2% in 2012 to 53% in 2019. The report also noted that in India, people who were unable to afford a healthy diet touched 973.3 million in 2020 or nearly 70.5 per cent, up from 948.6 million in 2019 (69.4 per cent). In 2017, about a billion people were unable to afford a healthy diet in India and this number has declined to 966.6 million in 2018

The report noted that subsidies to consumers provided in Lower Income Countries and Middle-Income Countries most often take the form of in-kind or cash transfers under the social protection programmes, agencies

# Amravati accused in NIA custody till July 15

Mumbai: Describing the killing of an Amravati chemistas an act of terror, the NIA on Thursday sought custody of the seven accused arrested so far: including the alleged mastermind. Referring to the beheading of an Udaipur tailor, it told the special court that a similar incident had taken place and it was about terrorising people, reports Rebecca Samervel.

Special judge A K Lahoti remanded the accused to NIA custody till July 15. The NIA had sought 15 days' custody saying there is "prima facie proof" of the involvement of the accused and of a deep-rooted conspirucy. The case had

Too much Vitamin D can be toxic

The incidence of toxicity caused by vitamin D overdose is on the rise. Dr Atul Gogis, sonior consultant, internal medicine, SGRH revealed. While sometimes the supplement is prescribed in higher dosage than needed, at times patients take it on their own, leading to toxicity. Dr Dines Rhullar, chairman and head of department, nephrology, Max Saper Specialty Hospital Sape ket, said he sees at least one case of renal dysfunction caused by vitamin D overdose on a monthly basis.

"Vitamin D deficiency is rampant, but we should correct it slowly and monitor it at regular intervals to avoid complications, such as acute kidney nigury induced by high calcium levels," he added, Vitamin D is an important prohormone that is vital for maintaining healthy bones and calcium levels.
