# No. of malnourished in India declined in 15 yrs

**United Nations:** The number of undernourished people in India has declined in the last 15 years to 224.3 million in 2019-2021, according to a UN report, which also said that there are more obese adults and anaemic women in the world's second most populous country.

The State of Food Security and Nutrition in the World 2022 report, issued on Wednesday by UN agencies Food and Agriculture Organisation (FAO), International Fund for Agricultural Development (IFAD), UNICEF, World Food Programme (WFP) and the World Health Organisation (WHO), said that the number of people affected by hunger globally rose to as many as 828 million in 2021, an increase of about 46 million since 2020 and 150 million since the outbreak of the Covid-19 pandemic.

The report said that in India, the number of undernourished people declined to 224.3 million in 2019-21 from 247.8 million in 2004-06. It said that the number of children under 5 years of age who are stunted declined to 36.1 million in 2020 from 52.3 million in 2012, the

number of children under five years of age who are overweight declined to 2.2 million in 2020 from three million in 2012. However, the number of obese adults in India, which has a population of over 1.4 billion, grew to 34.3 million in 2016 from 25.2 million in 2012 and the number of women aged 15 to 49 years affected by anaemia also grew to 187.3 million in 2019 from 171.5 million in 2012. The report added that the number of children up to 5 months of age exclusively breastfed touched 14 million in 2020 from 11.2 million in 2012.

In percentage terms, the prevalence of undernourishment in the total population

in India stood at 21.6% in 2004-06 and declined to 16.3% in 2019-21, the prevalence of stunting in children under 5 years of age declined to 30.9% in 2020 from 41.7% in 2012 and the prevalence of overweight children under five years of age was 1.9% in 2020 from 2.4% in 2012.

The prevalence of obesity in India's adult population increased to 3.9% in 2016 from 3.1% in 2012 and anaemic women aged 15 to 49 years declined from 53.2% in 2012 to 53% in 2019. The report also noted that in India, people who were unable to afford a healthy diet touched 973.3 million in 2020 or nearly 70.5 per cent, up from 948.6 million in 2019 (69.4 per cent). In 2017, about a billion people were unable to afford a healthy diet in India and this number has declined to 965.6 million in 2018.

The report noted that subsidies to consumers provided in Lower-Income Countries and Middle-Income Countries most often take the form of in-kind or cash transfers under the social protection programmes. *AGENCIES*

While China had earlier also expressed reservations over reports that India might host a G20 meeting in J&K or Ladakh next year, the MEA said there's no need to speculate about the venue at this stage. "India will assume the presidency of G20 from December 2022. Apart for the Summit next year, a large number of G20 events at different levels will be organized across the country during our presidency.

## 'No drones in prohibited areas'

A senior official from the state home department told TOI that the civil aviation ministry too, had issued guidelines against flying of drones in and around these installations. "Be it photography or survey or any other purpose, no drones will be allowed in prohibited areas. Areas within 5km of the KIA perimeter and 2.3km from the centre of Kaiga generating station have been declared drone zones," the official said. Violators will be punished under Aircraft Act of 1934, Aircraft Rules of 1937 and the Indian Penal Code. The state government has been empowered to invoke relevant sections of other statutory provisions.

## Amravati accused in NIA custody till July 15

**Mumbai:** Describing the killing of an Amravati chemist as an act of terror, the NIA on Thursday sought custody of the seven accused arrested so far, including the alleged mastermind. Referring to the beheading of an Udaipur tailor, it told the special court that a similar incident had taken place and it was about terrorising people, reports Rebecca Samervel.

Special judge A K Lahoti remanded the accused to NIA custody till July 15. The NIA had sought 15 days' custody, saying there is "prima facie proof" of the involvement of the accused and of a deep-rooted conspiracy. The case had

leads, not limited to Amravati, that it wanted to probe. Shaikh Irfan Rahim, 32, Muddasir Ibrahim, 22, Shahrukh Pathan Khan, 23, Abdul Tasleem, 21, Shoeb Khan, 29, Ateef Rashid, 23, and Yusuf Khan, 44, were brought to the city and presented at 5.40pm. # Murmu seeks backing of JMM for presidential race

Ranchi: The ruling JMM in Jharkhand on Monday laid out the red carpet for NDA's presidential candidate Droupadi Murmu, a move that marks an embarrassment for the opposition's joint candidate Yashwant Sinha. A likely switch of support of the Sorans to the NDA candidate comes after the statement of TMC chief and West Bengal CM Mamata Banerjee, who had said that she could have considered supporting Murmu if BJP had taken her into confidence before announcing its candidate. Sinha's name was proposed by Mamata. Odisha CM Naveen Patnaik was first from among the

non-NDA bloc to pledge support to Murmu, who hails from the state. Signs of rethink along with Mamata's friendly vibes towards Murmu suggest that NDA's choice may mark an important step towards the emergence of the confluence of tribals spread across states. Bhupesh Baghel, CM of Congress-ruled Chhattis-

garh, has also supported the idea of a tribal making it to the top constitutional office, though he said that he would have opted for Anusuya Oiké, BJP MP from his state. Murmu also received support from BSP, JDS and Akali Dal. During the meeting with the Sorans, Murmu asked for the support of their party's lawmakers. JMM has 38 MLAs and two MPs. On July 7, Mahua Majhi won the Rayra Sabha election, will be sworn in as the third MP. Murmu, who was Jharkhand's governor for six years, met Hemant and Shibu along with Union tribal affairs minister Arjun Munda and Union minister of state Annapurna Devi.

## 'Builder didn't get chance to rebut findings'

Appeals against NGT orders are to be filed directly in the SC. Appearing for Savabh Builttech, senior advocate Neeral K Kaul told the court that the NGT bench led by chairperson Justice Adarsh K Goel blindly relied on the report of the joint committee, without giving an opportunity to the builder to rebut the findings, and went ahead with imposing an arbitrary penalty in breach of the SC's guidelines on acceptance of reports of such committees by the tribunal. Present NGT chairperson Goel, when he was a judge of the SC, had in 2017-18 scrutiny and requested approval of Kant, then a Punjab and Haryana HC judge, as chief justice of the Himachal Pradesh HC on certain unverified property related allegations. Goel's reservations were overruled and Kant was appointed CJ. Later, when Kant's name was being considered for appointment as a judge in the SC, activist lawyer Prashant Bhushan had written to then CJ Ranjan Gogoi opposing it. However, Gogoi overruled the objections and the collegium headed by him recommended Kant's appointment as SC judge, which he became on May 24, 2019.

## Sr IPS officer held for role in recruitment scam in Karnataka

Bengaluru: Senior IPS of Goa Anuraj Paul, who is additional director-general of police (internal security division), was arrested here on Monday on suspicion of involvement in the police sub-inspector (PSI) recruitment scam. It is the first time in recent history in Karnataka that such a high ranking police officer has been arrested. Paul, questioned four times by the Criminal Investigation Department (CID) over his alleged involvement, headed the Karnataka police recruitment cell before being shunted out two months ago. He was subjected to a medical examination at the state-run Bowring hospital and produced before a court which remanded him in police custody for 15 days. Paul came under the scanner following the recruitment scam in which several candidates secured top ranks by indulging in malpractices, including tampering with the OMR/police mark recognition sheets after colluding with middlemen and some police officers handling recruitment.

## Restaurants, hotels barred from levying service charge

New Delhi: The Central Consumer Protection authority (CCPA) on Monday barred hotels and restaurants from levying service charges automatically on a data on food bills. It allowed customers to file complaints in case of violation with the consumer commissions, including through e-dashakriti, and even district collectors. The authority set up under the Consumer Protection Act, has issued detailed guidelines specifying the duties of restaurateurs and the rights of customers and termed levying of service charges as "unfair trade practice". It has prohibited the eateries to collect such charges in any other name. The CCPA also said hotels and restaurants must not link the entry of a customer and consumption of food to the service charge. This authority has said service component is inherent in the price of food, which covers both the material and service. "There is no need on hotels and restaurants to set the prices at which they want to offer food or beverages to customers. Charging anything other than the said amount would amount to unfair trade practice under the Act," said the guidelines.

## Bonny boy born hrs after docs say foetus dead

Almorat: A pregnant woman in Almorat was told by doctors of a local government hospital that her baby had died in the womb and needed to be removed by surgery. But a few hours later, in the ambulance on the way to another health facility, the 23-year-old woman went into labour and with the help of the medics present, gave birth to a healthy boy. "Terminating a case of negligence" by Chankhuti Hospital staff, the woman's kin claimed that when she was told to go to Rankhet for the surgery, her condition began to deteriorate. Leela Devi, an anganwadi worker, said that doctors, after a brief examination, told the family on Sunday that the child's heartbeat had stopped. Leela added, "There was no facility of delivering a still-born," so the woman was referred elsewhere. Disappointed, her family took her in the ambulance, when after travelling for about 2 km, the woman gave birth to a healthy baby.

## Too much Vitamin D can be toxic

The incidence of toxicity caused by vitamin D overdose is on the rise. Dr Atul Gogoi, senior consultant, internal medicine, SGRRH revealed. While sometimes the supplement is prescribed in higher dosage than needed, at times patients take it on their own, leading to toxicity. Dr Dimesh Khattar, chairman and head of department, nephrology, Max Super Speciality Hospital Saket, said he sees at least one case of renal dysfunction caused by vitamin D overdose on a monthly basis. "Vitamin D deficiency is rampant, but we should correct it slowly and monitor it regularly to avoid complications, such as acute kidney injury induced by high calcium levels," he added. Vitamin D is an important prohormone that is vital for maintaining healthy bones and calcium levels.

**CBSE airlifting answersheets from flood-hit states**

New Delhi: The wait for CBSE Board exam results could get longer as the compilation process is yet to be completed by the Board which is set to get an advanced answer-sheets from all the centres. As per the initial plans, the results were supposed to be announced around July 10, 2022, but CBSE sources said there could be some delay. While over 31 lakh (Class X and XII) board exam candidates await their results, especially the Class XII students seeking admission to various undergraduate programmes, CBSE officials are non-committal as of now on any dates for declaration of results. According to sources, CBSE is now getting the answer-sheets airlifted from states like Assam which is reeling under floods. "From regions like the North East, especially Assam where there is floods, getting the evaluation done has been an issue and we are using helicopters to bring the answer sheets," said the official.
