AERA warns airports against arbitrary charges on charters

Making Non-Aeronautical Services Mandatory Violates Law: AERA

Ahmedabad: The Airports Economic Regulatory Authority (AERA) recently warned airport operators against imposing non-aeronautical charges in violation of provisions of the AERA Act 2008.



The city airport operator has imposed a Rs 50,000 decongestion charge per charter in addition to a non-aero ancillary charge of Rs 17,857 per passenger plus 18% goods and services tax (GST).

The warning notice was issued soon after Adani Group increased charges levied on charter flights at Ahmedabad airport during the ongoing ICC World Cup. Sources said these arbitrary charges were levied at the Adani-run airports in Ahmedabad, Lucknow and Jaipur, under the heads of 'decongestion charges' and 'non-aero ancillary charge per passenger'.

"It has been reported by stakeholders that some airport operators are levying charges for non-aeronautical services (Elite Meet and Greet Service), which are otherwise optional for charter flights, aircraft operators and making them a prerequisite for availing of aeronautical services. Making such non-aeronautical charges mandatory

to Adani Airports on Thursday went unanswered. "These charges increase the cost of travel by at least 40%. For instance, an Ahmedabad-Mumbai 10-seat charter flight which costs Rs 13 lakh plus 18% GST will now cost at least Rs 5 lakh extra. This raises costs and affects bookings," said a source in a charter aggregator.

A city-based businessman recently chartered a flight from Ahmedabad to Udaipur and ended up paying Rs 21,000 as a 'name-change fee' to change the name of a flier.

"Arbitrary per passenger charges were imposed by the airport operator before the ICC Cricket World Cup matches were held in Ahmedabad. At a time when there is shortage of aircraft across the country and demand is increasing, such charges deter growth of the charter business and services," a charter operator said.

Manali-Leh highway shut due to snowfall

Kullu: The Manali-Leh national highway was closed on Friday as higher reaches of Himachal Pradesh received fresh snowfall, causing a sharp drop in the temperature all over the state. According to Leh-Spiti Police, the highway was closed beyond Leh following heavy snowfall since Thursday evening. The road from Koksar to Rohtang pass, which also received fresh snow, was closed by the police as well.

In an advisory, the police department cautioned people against driving in the present snow conditions in the three districts. A police officer said that the Manali-Leh highway condition between Barot and Sarchu was unfit for vehicular movement due to continuous snowfall. Atal Tunnel, a popular tourist spot, and the nearby Sissu village also received the season's second snowfall on Friday. Some tourists who had reached the Atal Tunnel in the morning were asked to return to Manali as the road condition began deteriorating. The upper reaches of Kinnaur, Shimla and Chamba also received snowfall and it rained in the state's mid and lower hills. As per the weather department, Dalhousie received the highest rainfall of 40mm by 5.30pm on Friday, followed by 20mm in Kangra, 17mm in Una, Hamir and Sundernagar and Himachal Pradesh.

According to the weather department, most parts of the state recorded a drop in the maximum temperature on Thursday. Shimla recorded a maximum temperature of 15.2°C (a departure of 2.4°C from normal). Una 10°C (0.4°C difference), Manali 9°C (departure of 5.3°C), Chamba 14°C (a difference of 14.1°C), and Dharmsala 18°C (4.7°C lower than normal). The lowest maximum temperature of 7.7°C was recorded in Keylong on Friday.

Bengal AG emails resignation to gov

Kolkata: Bengal advocate general (AG) S N Mookherjee on Friday resigned from office without giving any reason for abruptly cutting short his more than 25-month-long tenure. Mookherjee, who is currently on holiday abroad, emailed his resignation to governor C V Ananda Bose.

"Yes, I have resigned," he said when TOI got in touch with him, refusing to elaborate. "I have not mentioned any reason in my email to the governor. So, I do not wish to speak on it," he added. Mookherjee is set to return to Kolkata on November 17.

A Cambridge University law graduate, Mookherjee had completed his law at Lincoln's Inn, London. He had become the AG in September 2021, replacing Kishore Dutta, who had then resigned citing "personal reasons". Sources said Dutta is among the forerunners to replace Mookherjee as advocate general. There was no formal statement on the appointment, neither from the state government nor the governor.

An AG's tenure is usually for five years, though it has been shorter in the past several instances. Anindya Mitra, Jyotsna Mitra, Bimal Chatterjee, Dutta and now Mookherjee have all put in their papers as AG before the five-year tenure ended. Mookherjee's father, Sabyasachi, known in the legal fraternity as Jalu Mookherjee, was a Union Minister of state in the Jayaprakash government. He was also Bengal BJP president.

Farmer thrashed to death by cops in UP

Bareilly: A 49-year-old farmer, who was returning from his fields, was allegedly thrashed to death by seven cops who suspected him to be a gambler. The incident happened on Thursday evening. The farmer, Santosh Sharma, from Bhamora village in Bareilly district, was admitted to a private hospital where doctors told his son that he had slipped into coma "due to head injuries caused by a blunt object". He died on Friday evening.

Sharma's family alleged that officials at Bhamora police station initially tried to hide the incident. His son Suraj told TOI, "My father was innocent but the policemen thrashed him to death because we were making inquiries on his behalf. They should be charged for murder". After the family lodged a complaint on Friday, SSP Sushil Ghule Chandrabhan suspended seven cops, including outpost in charge Tinku Singh. Speaking about the matter, additional SP, Kanwardeep Singh, said, "After we came to know about the incident, we tried to ensure the best possible treatment for the farmer but he couldn't survive. The family has claimed that he was a victim of police atrocity. An FIR will be registered against the cops if they are found guilty."

Odd-even: SC leaves it for Delhi govt to decide

New Delhi: The Supreme Court on Friday left it for the Delhi government to take a call on odd-even curbs on movement of vehicles, even as it remained sceptical about its efficacy and maintained that stable burning in neighbourhooding states is the main reason for the foul air in the capital.

"No matter what you want to do but we are flagging its minimal impact. You have to take a call," the bench told the Delhi government even as it expressed displeasure over the AAP government for saying that it would wait for the court to give its nod. Appearing for the Delhi government, senior advocate Meenakshi Arora told a bench of Justices Sanjay Kishan Kaul, Sudhanshu Dhulia and Abanindranath Aiyangar that odd-even programme is effective as an emergency measure during winter months when car emissions play a more prominent role in polluting the air. She contended that the scheme did make a difference in the past as vehicular pollution reduced by 18 per cent and it also led to decongestion of roads.

Sisodia gets nod to meet ailing wife

Delhi: court on Friday allowed former deputy CM and jailed AAP leader Manish Sisodia to meet his ailing wife, for six hours today. Sisodia, an accused in cases pertaining to alleged irregularities in the liquor policy, had moved an application and sought permission to meet his wife who is suffering from multiple sclerosis, for five days. The CBI and ED opposed the application. Earlier this year, Sisodia was given permission to meet his wife. But by the time he reached his house from Tihar on June 5, she had to be rushed to the emergency ward of LNJP Hospital after her condition worsened.
