COMMUTER BIKES DROPPED

Suzuki launched the 155cc Intruder cruiser (at Rs 98,340) on Tuesday and plans to launch scooters and a high-end 600cc-plus cruiser bike later this fiscal. "Going forward, we are going to focus on the higher end 150cc and above motorcycle segment and scooters. We have only one commuter bike — Hayate — which sells 500-600

units in some north Indian markets and is also exported. We will not update that model to be BS6-compliant after 2020," said MD Uchida.

The shift in focus — from commuter bikes to scooters and bigger bikes — becomes obvious from the company's long-term targets. "We want to hit 1 million units by FY19-20, of which 8,00,000 units will be scooters and 2,00,000 motorcycles," said Uchida. "Our current plant near Manesar has a peak capacity of 1 million units and once we cross that we will think of another plant," he added.

The company is focusing on scooters because of growth in that segment.

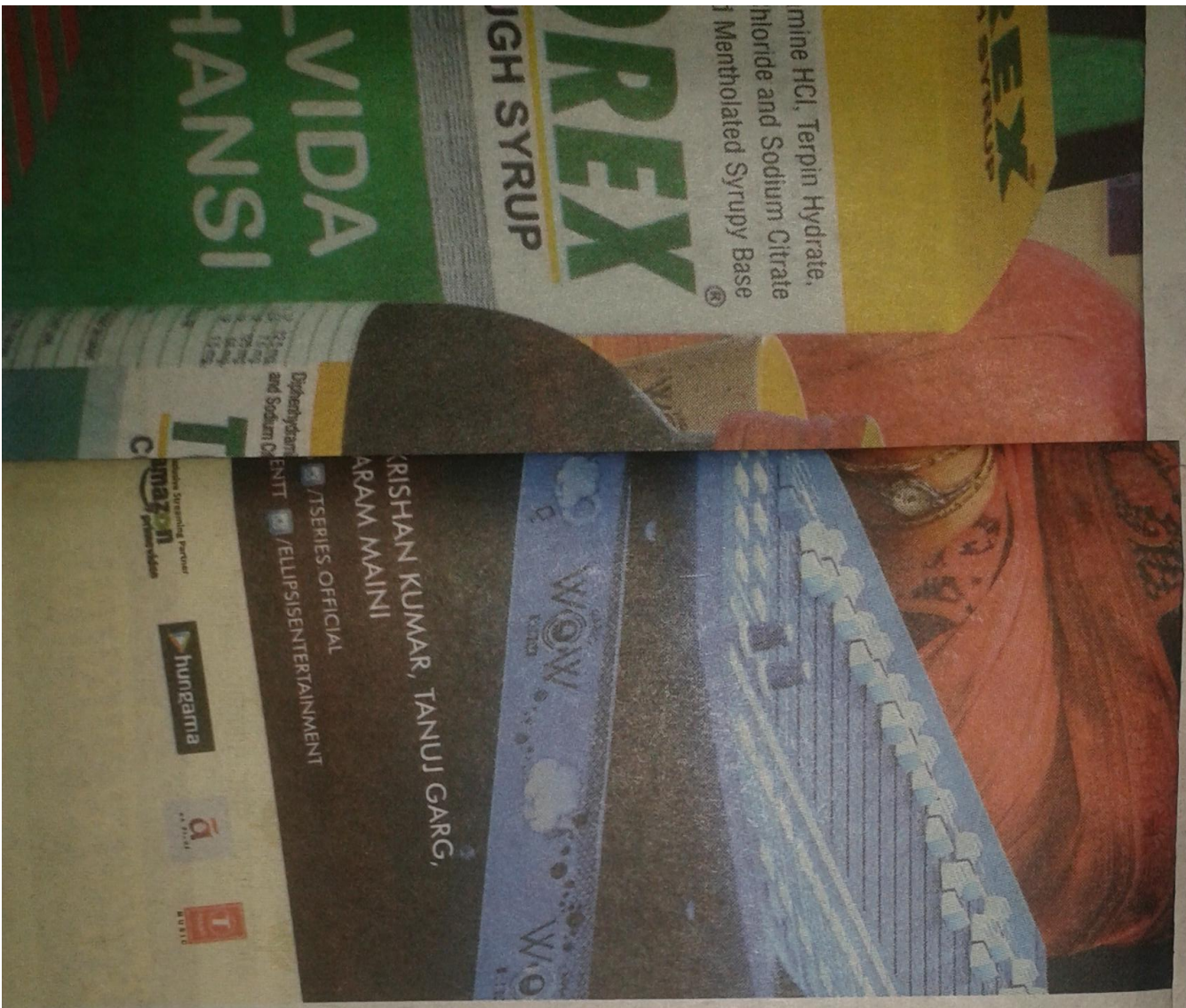
